Minutes of the Previous Board Meeting

- 1. October board meeting minutes were read and approved.
- 2. John Bilotta raised the possibility that minutes be read, and corrections and approval sent by e-mail prior to the meeting. Decision was deferred.

Treasurer's Report

- 1. Sheli Nan presented the treasurer's report as of November 10, 2021, and it was approved.
- 2. Means to enhance donation requests were discussed, including more visible mention at concerts. Sheli proposed that she create a draft donation letter for review.

Status of Upcoming 2021-2022 Concerts

- 1. John Bilotta presented the current plans for the 2021-22 season:
 - a. Avenue Winds Concert
 - i. John reported that the concert was a good success, great music, with
 - about 49 people attending virtually and positive comments received by e-mail.
 - b. Composers & Friends I February 2022, submissions due around January 1
 - i. The risks of trying for a live concert were discussed. A decision was deferred until John Bilotta can discuss with Davide, who handles the call for scores.
 - c. Composers & Friends II April 2022
 - d. Presidio Chapel Concert April or May, 2022, streaming and live.
 - e. Hired Ensemble Concert June, 2022
 - i. John Bilotta presented the tie-breaker vote results: 9 votes for Pierrot, 6 for brass quintet, 4 votes each for Ives Collective or Divisa Ensemble.
 - ii. It was discussed that choice of an existing ensemble may be less costly and get better musical results.
 - iii. John Bilotta proposed that he get quotes from potential Pierrot and brass ensembles to see what is economically feasible.
- 2. Live, pre-recorded, and hybrid live/streaming concert models were discussed.
- 3. Financial models for live, streaming, and/or season ticket sales were discussed.

Shawne Workman presented draft pre-announcement materials for review. The contest schedule was corrected to reflect performance of winning pieces in fall 2022 rather than June.
