
- I. Approved Minutes of Previous Board Meeting

- V. New Membership Benefits

  - b) Fiscal Sponsorship. Purpose: allows individual members to submit grant applications when granting agency requires non-profit status. Board votes and approve: "NACUSA/SF can provide fiscal sponsorship for NACUSA/SF members to submit grant applications when a

granting agency requires non-profit status." Davide will send a sample contract to John (Bilotta), Bilotta will contact the Cascadia chapter for mor info. The board will decide on details at the next board meeting.
